### **Important Info**

Daycare is available from 7am to 6pm, Monday through Friday. At 6pm dogs may be moved to the kennel area to relax and wait for pick up. You may pick up your dog until 7 pm. After 7pm late fees may apply.

Sometimes a dog needs a break from the daycare floor. In this case your dog will be given some down time in the kennel area. This is normal. If your dog needs breaks because of a problem we will let you know.

Most dogs enjoy daycare for the first few years of their life. As they age dogs tend to need less exercise and naturally become less social. As your dog reaches social maturity they may no longer enjoy attending daycare. We will be sure to keep you apprised of your dogs behavior as time goes by.

All dogs must be non-aggressive and not food or toy possessive. We reward good behavior with treats and will attempt to modify undesirable behavior as much as we can. Dogs who become aggressive or over aroused will be given a a break in the kennel area. WOOFS! reserves the right to remove any dog from daycare if they injure or attempt injure another dog or person or if they become too difficult to manage in the daycare environment. Excessive barking may also result in dismissal.

## **Daycare Information**

 _ AGE: Dogs must be at least 9 weeks old.
 _ <b>GENDER:</b> All dogs over the age of 6 months <b>MUST</b> be spayed or neutered.
 _ <b>VACCINATIONS:</b> Owners are required to provide proof of current vaccinations. Puppies must have their first two rounds of Distemper and Parvo. Adults should have DHPP and Rabies. Bordatella is recommended.
COLLARS: All dogs are required to wear a quick release collar and identification tag (no buckle collars allowed).
_ <b>HEALTH:</b> All dogs must be in good health. Sick dogs will not be permitted in the building. Do not bring your dog to daycare if they are vomiting or have diarrhea. All dogs must be on a flea prevention program. We reserve the right to trim your dogs NAILS at a charge of \$10 if they are too long.
<b>LUNCHES:</b> Only puppies under 4 months of age are eligible for lunches during daycare. We do not feed lunch to dogs over 4 months of age because it makes them more susceptible to bloat, which can be fatal.
 WATER BREAKS: To maintain safety and cleanliness, and as a precaution against bloat, water is offered several times a day but is not freely available. It is likely that your dog will be thirsty upon arriving home.
RISKS: Owner acknowledges that there are risks inherent in keeping dogs in daycare settings, including risks to the health and wellbeing of the dog(s) as well as risks that the dog(s) may harm people, dogs or other property. WOOFS! is not responsible for any injuries or illness your dog may obtain in daycare.
<b>EMERGENCY:</b> In case of emergency your dog will be transported to Shirlington Animal Hospital located at 2770 S. Arlington Mill Dr. Arlington, VA 22206 <a href="https://www.shirlingtonanimalhospital.com">www.shirlingtonanimalhospital.com</a> .
FEES: Half day rate (up to 6 hours) = \$27 per day. Single full day rate = \$38 per day. Discounted multiple day passes are available. 5 day pass = \$185 (\$37 per day) 10 day pass = \$360 (\$36 per day) 15 day pass = \$525 (\$35 per day) 20 day pass = \$680 (\$34 per day) 30 day pass = \$960 (\$32 per day). All daycare passes expire 6 months after date of purchase. Passes are non-refundable & non-transferrable. Daycare payment is due on the day services are rendered.
 _ HOURS: Shirlington Campus: Monday- Friday from 7:00am - 6:00pm. Dogs may be picked up until 7pm.
 LATE PICKUPS: A late fee of \$22 applies to any daycare dog picked up after 7 pm.

### WOOFS! Daycare / Boarding Agreement:

Owner agrees to pay the current rate for daycare and boarding in effect on the date the dog(s) listed below is (are) checked into WOOFS! Dog Training Center's ("WOOFS!") facility. Prices are subject to change at any time, without notice. Owner shall remain liable for the entire outstanding daycare and boarding fees as well as other fees and charges incurred in the care and maintenance of the Dog(s) placed in daycare with WOOFS!.

Owner acknowledges that there are risks inherent in keeping dogs in daycare and boarding settings, including risks to the health and well being of the Dog(s) and well as risks that the dog(s) may harm people, dogs or other property. The Owner agrees to be solely responsible for any and all acts or behaviors of the Dog(s) while in the care of WOOFS!, including but not limited to any acts that damage or in any way harm any person, other dogs or property of WOOFS! or any daycare and boarding customer. Owner agrees to indemnify and hold WOOFS!, its employees, agents, staff and representatives harmless against all any and all claims and liability incurred by reason of a Owner's breach of this agreement and any acts of the Dog(s) and shall pay all costs and reasonable attorneys' fees incurred. Owner agrees to pay all costs and reasonable attorneys' fees incurred for any efforts to collect amounts owed to WOOFS! by Owner under this Agreement.

Owner hereby warrants that the Dog(s) are current on all required vaccinations, including without limitation, Distemper, Parvo, Bordatella and Rabies. Valid proof of vaccinations and/or titers must be presented before the Dog(s) can be dropped off for daycare or boarding. Owner agrees to maintain vaccinations and to provide WOOFS! with updated copies of vaccination records as they become available.

Owner agrees that Dog(s) arriving with fleas, ticks or other infestations shall be sent home. WOOFS! reserves the right to refuse any dog.

Owner agrees that the Dog(s) will be picked up by Owner or a pre-approved Owner's agent by closing time (7 pm) unless an extension is agreed to prior to 5:00 pm on the day of service. In case of an emergency which would delay Owner's arrival, Owner shall promptly notify WOOFS! of such a delay. If WOOFS! is unable to provide for the Dog(s)' care during such delay, owner shall immediately make alternate arrangements for the Dog(s)' pick-up. In any event, late charges will be assessed.

WOOFS! Dog Training Center agrees to exercise reasonable care in caring for the dog(s), and to keep the premises sanitary and properly enclosed. All Dogs are handled or cared for by WOOFS!' staff without liability on WOOFS! part for loss or damage from disease, theft, fire, death, escape, injury or harm to person's, other pet(s) or property by said pet(s), or from other unavoidable causes, due diligence and care having been exercised.
